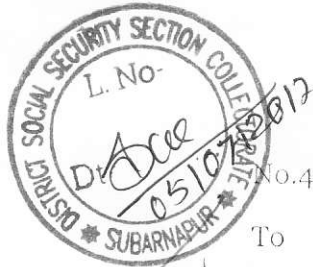

Madam/Sir,

I am directed to say that Government of Odisha in Higher Education Department is implementing the "Green Passage" Scheme from the academic session 2016-17. Certain changes in the Scheme have been made which require your immediate attention.

1. Instead of the word "Orphan", used/described under Clause[42] of Section 2 of the Juvenile Justice(Care and Protection of Child) Act,2015, the following connotation may be used: "A child who is without biological or adoptive parents and the child is residing in Child Care Institution or under foster care or care of a guardian or any fit person whose annual income from all sources does not exceed Rs 1.00 lakh".
2. Instead of Collector/Sub-Collector, the Tahasildar of the locality is designated as the competitive authority for issue of the "Certificate to avail benefits under Green passage as per Resolution No.23836,Dated 29.10.2015 of Higher Education Department".
3. The candidate/ applicant intending to avail facilities under the Green Passage may apply to the competent authority in the prescribed format[Annexure-I] for issue of the "Certificate to avail benefits under Green Passage as per Resolution No.23836, Dated 29.10.2015 of Higher Education Department" and submit the said Certificate along with the Application Form for admission in College/University.

In case of difficulties in obtaining the said certificate, in respect of a candidate/applicant who has already applied for the purpose, he/she may submit an undertaking accordingly and the case may be allowed subject to the production of the relevant certificate within a period of three months from the date of filing of the undertaking.

Format for Undertaking:

I, _____ (Name of the applicant) undertake to submit the certificate to avail benefits under Green Passage Scheme of Government of Odisha in Higher Education Department from the competent authority within a period of three months from the date of filing of the undertaking, failing which the benefits claimed under the scheme will be withdrawn.

Signature of the Candidate

Copy of *Annexure-I* and the above Undertaking should be handed over to the Admission Committee/Authority of the Institution, who will allow them to take admission.

4. On submission of application accompanied with the said certificate "the fees" may be exempted at the time of admission in case of Government Institutions and in respect of non-Govt. Aided Institutions, the said fees may not be claimed from the eligible applicant, but will be reimbursed by the Higher Education Department to the said Institutions on being claimed in this regard.
5. All types of fees including application fees, admission/re-admission fees, tuition fees, examination fees, hostel admission fees, laboratory fees, college development fees etc. may be exempted.
6. The time period to issue the certificate will be same as applicable for issuing Caste certificate/other certificates by the Revenue Officers.
7. Any Officer of the Higher Education Department assigned by the Principal Secretary/ Commissioner-cum-Secretary may be the **Authority** to decide the matter in connection with the "Appeal", which may be disposed of within **15** days.
8. Three annexures may be used for the purpose.







Orphans remain a pressing challenge for many countries. In India, about 20 million children are orphans and in Odisha, there are 16,382 orphans living in 272 child care institutions. Orphans have many needs and one of the most important needs is education. Education is critically important to children's social integration and psycho-social wellbeing. Education is a basic human right for all children as recognized in the convention of the Rights of the child. A child who has access to education has a better chance in life.

Therefore, State Government have decided to provide free education to orphan students starting from +2 to Post-Graduate so as to enable them to complete the higher education and compete for better livelihood.

1. Identification of orphans:

- a) A complete database of all the orphanages will be created with the help of District Collectors.
- b) Identification of orphans would require necessary certificates from District Collectors/Sub-Collectors.
- c) The college authorities will submit the detail data of the orphan students with their demands after enrolment of these students
- d) The assistance will be reimbursed by the Department of Higher Education.

2. Exemption of Fees:

- a) The exemption of fees include admission/re-admission fees, tuition fees, examination fees, hostel admission fees, laboratory fees, college development fees.
 - b) This is applicable for both Govt. and Non-Govt. Aided institutions (College & University).
 - c) The college /University authorities will provide free accommodation and food to such students, which will be reimbursed by the Government as per the norm decided.
3. Their progression in higher education will be tracked by the Higher Education Department till they complete their education.
